Equity and Practice Transformation Provider Directed Payment Program Practices Selected in 2024

This notice is to provide information of public interest about the primary care practices accepted in 2024 to the Equity and Practice Transformation (EPT) Provider Directed Payment Program. This program supports delivery system transformation, specifically targeting primary care practices that provide primary care pediatrics, family medicine, internal medicine, primary care OB/GYN services, or behavioral health services that are integrated in a primary care setting to Medi-Cal members. This includes implementing practice infrastructure, such as electronic health record systems, data collection, recording capabilities, improved data exchange, and implementation of care management systems. The practice names, Managed Care Plan (MCP), counties, and type of practice were self-reported by the accepted practices.
